- Qualifying equipment must have received LADWP approval prior to purchase, installation, and operation.
- Rebates will be reserved on a first-come, first-served basis until funds are exhausted.
- Projects not completed within 90 days of LADWP pre-approval may be cancelled and reserved rebates returned to the program fund.

- Wait to receive LADWP approval BEFORE starting your project.
- Notify LADWP when the installation is complete.
- Submit all required documentation required in application.
- Upon final approval, LADWP will mail a rebate check. Please allow 4 to 6 weeks for LADWP to process your rebate check.
